

Introduction

It introduces a new solution to the current limits, for Free Flow systems, both Italian and international ones.




User Experience


The use is very simple: during the enrolment or in his personal area in the APP or in the Web Portal, the consumer will connect the license plates of his interest to his IBAN and then enter his PIN (biometric, numeric, vocal etc...)

In this way the system will check all data and validates the authorization flow which will allow access in all the gates enabled for the service.


Easy 2 use: operating technical scheme



OPENING CONTROL AND SCHEME

The infrasctructure is already equipped with cameras to check vehicles license plates.

The barrier will open by the use of a detection software.
